If in total we can turn 750 thousand new peasant farms into entrepreneurs, land owners, then in the village a lot of social problems are solved, first of all, the issue of unemployment and poverty. I insisted that I believe in our president.

It is difficult to name a country that does not affect the problem of migration. Donor countries, like receiving countries, are involved in the whirlpool of modern migration flows. International migration does not cease to cover the countries of the European Union with new waves, the leaders of which, in turn, incessantly bring new conflicting ideas. Some talk about a multicultural society, tolerance and possible assimilation of immigrants, others are completely negative and in every possible way criticize policies loyal to the coming foreigners. These polar opinions are not resolved, but only reveal problems and difficulties associated with new members of society and draw public attention to the inevitably arising difficulties associated with the difficulties of assimilating foreigners to a new society.

According to the latest data published by the United Nations Department of economic and Social Affairs (UNDESA) in the report on the state of world migration, the number of immigrants is constantly growing and by 2017 is about 258 million, which reflects migration growth. The largest number of immigrants lives in the USA (49.8 million people), Saudi Arabia and Germany (12.2 million immigrants each). Migration is a very serious problem for Russia. After the collapse of the Soviet Union, millions of ethnic Russians became citizens of sovereign states, which were previously Soviet republics. Most of them were forced to move to Russia. In 1980, according to statistics from the Institute for Migration Policy, there were about 3251 thousand immigrants for the entire USSR. Ten years later, only in the Russian Federation, according to the UN, the number of immigrants exceeded 11,500,000, which is 7% of the country's total population [23].

No modern election campaign would be complete without migration theses. Sometimes the positions of future leaders in this regard are absurd in nature, for example, the former US President D. Trump's promise to build a wall between the United States and Mexico. However, the thesis on migration and migrants, as a rule, is put forward by all candidates for higher political positions as a necessary component of any political program. Responses to high-level statements and news in the field of migration policy appear immediately. Thus, threatening an international conflict, the Mexican government will not and will never allow the construction of a wall along the border. In addition, it is clear that the construction of stone fences will not be an effective way

to solve problems in the new information millennium, in the age of electronic technologies. "Migration serves as a clear barrier to British society. Moral feelings are expressed in a person's relationship to other people, the community and his social duties. When a person experiences these feelings, he evaluates other people's behavior or mental characteristics and his own behavior based on a certain morality, that is, a set of social morals and norms. Faced with the choice of a separate development by joining themselves in the European Union and blurring their personality or preserving the latter, the British choose their own path, which in the future can bring them even closer to the main British partner researcher N. A. Medushevsky.

The vote for Britain's exit from the European Union dealt a serious blow to the image of the European Union, whose members could never agree and achieve solidarity in the implementation of various migration programs and achieve deepening cooperation in the field of migration. Team mood-a complex of emotions that arise in team members in relation to this or that phenomenon, team mood has a huge power of influence, which is the motive for the behavior and activity of military personnel. While some types of Team mood (passion, confidence in success, high spirits) are factors in its success, others (bad mood, distrust of one's own strength, boredom, sadness and dissatisfaction), on the contrary, reduce the capabilities of the team.<sup>2</sup> As noted above, the central role in the support of the Brexit population was played by the migration process in Europe, which caused many conflicts at different levels.

Despite this, the former President D. Trump will not abandon attempts to stop illegal migration to the United States. Thus, after New decisions initiated by the American leader, since may 2018, All persons who arbitrarily crossed the US border, including those who were not previously arrested, are considered offenders and imprisoned. At the same time, special attention deserves the fact that underage children are separated from their parents and kept in special children's centers organized by the Ministry of Health. For the first time during the reign of former President Barack Obama and his predecessors, illegal immigrants who did not have documents arrested when crossing the border were released and subsequently received an order to appear in court. However, the administration of the current American president shows that in most cases, such immigrants will later "dissolve" in society, never in the Air Force Information Service to the court, ignoring draft papers, as noted [12].

A policy was chosen to completely abandon labor migration in the country and gradually end its importance as a type of replenishment of the country's If we analyze the neuromuscular basis of these emotions, we can see the following. For example, a melody that we like so much may not please a person of another nationality. According to official statistics, in 2019, 2.5 million people or 7% of the population of Uzbekistan are labor migrants. Of these, about 2 million citizens work in Russia. The money sent by labor migrants was US \$ 5.1 billion, or about 10% of the country'S GDP. In doing so, each immigrant earned an average amount of us \$ 166.7 per month. At the end of 2017, the number of immigrants decreased significantly and amounted to about 705 thousand asylum seekers in the member states of the European Union (EU). There are a number of effective ways to manage conflict situations. They can be divided into the following large group.<sup>4</sup> Syria remains the main country of asylum seekers citizenship in the member states of the European Union in 2017, a position that has been held every year since 2013. In 2017, the number of Syrian applicants for asylum for the first time decreased from 335 thousand in 2016 to 102 thousand. Iraqis made up 7 percent of asylum seekers, 7 percent of Afghans, 6 percent of Nigerians and Pakistanis, and 5 percent for the first time. Of the 198 thousand applicants registered in 2017, Germany accounted for 31%-28% of all applicants in the European Union. Many defense mechanisms are quite unconscious - meaning most of us don't even realize we're using them right now. Some types of psychotherapy can help a person learn what defense mechanisms they are using, how effective they are, and how to use less primitive and more effective mechanisms in the future. Then Italy (127 thousand or 20%), france (91 thousand or 14%), Greece (57 thousand or 9%), Great Britain (33 thousand or 5%) and Spain (30 thousand). or 5%).

In Russia, they watched with great concern the development of the migration crisis in Europe. What was characteristic of the speeches of the Russian authorities was the fact that the migration crisis was actually provoked by the European Union itself, opening the doors to immigrants very widely. Any form of behavior can be explained by internal and external causes. In the first situation, the psychological properties of the subject's behavior appear as the initial and final conditions of the explanation, and in the second - external and operational conditions. In the first situation, we talk about motives, needs, goals, wishes, interests, etc., and in the second - about incentives arising from the situation. Sometimes all factors that determine human behavior from the inside are called personality dispositions. Accordingly, dispositional and situational motivations are spoken of as internal and external analogs of behavior determination. That is why the desired action of a person is considered as twofold: dispositional and situational determination.

These are huge numbers. In different words, the income generated by labor migrants is about 20 percent compared to the gross domestic product of Uzbekistan. Naturally, Uzbekistan will not be able to provide such an amount of labor migrants with work or a decent income. So, even if a second path is chosen in solving the problem of labor migrants, it must be carried out in a certain sequence in stages, but consistently and decisively, using various highly effective organizational and economic (administrative, if necessary) tools.

We have found it necessary to state some of our opinions and suggestions on the solution of the problem of labor migration.

First offer. To carry out a policy of carrying out labor migration in limited quantities only in exchange for the export of qualified labor. It is gratifying that in the following times, our state, personally the head of state, pays great attention to issues related to labor migration. Recently, the president of the country Sh. M. The signing by Mirziyoyev of the decision "on measures to

introduce a safe, orderly and legal system of labor migration" is a vivid proof of my opinion. This decision, under the leadership of the president, is a bold step aimed at improving the well-being of the people by the state, increasing the international prestige of our state, and excluding the ills and shortcomings of labor migration, which has incorrectly formed the country and does not give us good results.

In our view, to regulate labor migration, it is necessary to create a mechanism for training hired, qualified workers and specialists in accordance with orders from countries importing labor, large companies, directly headed by the Ministry of poverty reduction and employment of Uzbekistan.

In this case, talented young people with professional qualifications and skills are selected on a competitive basis, they are taught the language, history, traditions, traditions of the country in which they should go and work for a certain period, the necessary skills and abilities in the chosen work, profession, profession are formed so that the migrant has the training that he can perform The establishment of labor exports on a scientific basis is of great interest to the Republic:

First, the amount of income from labor exports increases dramatically;

Two by two, young people have an increased interest in becoming a skilled worker or a qualified professional, that is, in studying well;

Thirdly, in young people, there is an increased tendency and experience in learning foreign languages;

Fourthly, young people who have done qualified work abroad, upon returning to their homeland, will have the opportunity to make a worthy contribution to the prosperity of the national economy.

Second offer. Solving the problem of unemployment in the country, providing those employed in the economy with decent wages directly depends on the pace of economic growth. Therefore, the introduction of a procedure for increasing the salaries of statesmen, officials in responsible positions, party leaders, profesor-teachers and scientists in harmony with the pace of economic growth in the country. The reason is the economic growth of the country, the growth rate of the national economy, as well as the ability to make a living, living in the bosom of the family and parents in their homeland, depriving themselves of the happiness of working hard, honestly working in foreign lands with Ne-ne hardships, withstood all discrimination and insults when it comes. When production is consumed, products in the form of resources are sent to production, become additional factors and expand it. Investment, in its material form, is, of course, nothing more.<sup>7</sup>

Third offer. Adoption and introduction into practice of laws on the" wage minimum "and" subsistence minimum". This measure is one of the most important tools not only to reduce the number of people wishing for labor migration, but also to implement a strategy to combat poverty, which was created in the country and whose distribution among market entities was loim, by raising the share of hired workers in national income at a reasonable level in Justice. When pouring young soldiers into the ranks, the help of senior soldiers in military units and units should be used. Large soldiers are considered stable carriers of traditions formed in the division. Their knowledge and experience can also be used to build crews as well as to attach to young soldiers.

"When people come to our country illegally, we must not gradually send them back without spending them on various legal procedures. Our laws are the most stupid in the world. Republicans want reliable borders and protection from crime. Democrats want open borders and

defenselessness in the face of criminals!"- said the American president on June 30, 2018 in his official Twitter account. Many Americans, especially conservative-minded people, applaud Donald Trump's promise to build walls on the border with Mexico. However, a large part of the American population opposed what was called "Trump's migration policy", going out to rallies and closing the streets of the largest cities with posters, among which there is an inscription "we are all immigrants", a clear reference to American history, known as the "country of immigrants".

Among the main political organizations involved in the campaign are the American Civil Liberties Protection Union, the Civil Liberties Conference, and the National Workers Alliance. Many celebrities expressed their support for the participants: Julianne Moore, America Ferrera, Natalie Portman and Lin-Manuel Miranda [12]. Thus, Donald Trump's promises on the issue of migration are still open: a wall with Mexico has not been built, initiatives are already facing sharp criticism and are practically not implemented, which negatively affects the rating of the US President. There is a specific basis for the division of group members with "conflict-of-regulation relations" related to the hierarchy within an unregulated group. These are, for example, the time spent in a group, age, gender, place of residence before entering a social organization, etc. In this case, the object of —relations contrary to the charter" is a person who does not accept the existing hierarchy or does not achieve informal status in the group, allowing him to take an equal position with the rest of the group. According to an All-Russian survey conducted by the Levada Center in March 2016, 42% of respondents supported the idea that "when attacked by terrorists, Europe will be "worthy", because instead of fighting the threat of terrorism, it prefers to fight against Russia."

Sociologist Karina Pipia said that every second respondent expressed the opinion that refugees arriving in European countries should not join the host (European) Community. Strict stratification within the group is associated with the conditions for the existence of closed communities: firstly, the group is faced with the need to solve most of the problems that arise with its resources, and secondly, the group is deprived of the opportunity to redirect. negative emotional stress accumulated from the outside. Also, the hypothesis that the negativism of the population of Russia in relation to the situation with refugees in Europe is determined by the general negative nature of perception by respondents of Western countries against the background of the ongoing disagreements and contradictions of Russia and the West is not unfounded.

It is necessary to provide them with practical assistance to farms in the territory of the district, scientific and methodological support, turn them into lokomatists of their development on an innovative basis. The solution of the current problems of today, such as the industrial processing of raw materials produced in the territory of the district and the transformation into finished products, the preservation of nes-dying agricultural products, the organization of their export to foreign markets, should become the most important areas of activity of State Farms. Or, another example: there were much more difficulties with getting used to them when graduates of training units were sent to serve in parts other than those from which they themselves passed the practice of military service. <sup>11</sup>

In order for the goods and services created in the national economy at the cost of large resource consumption and hard work of our people to be competitive in the global market, they must, firstly, be of high quality, and secondly, be cheap in price (Chinese experience). The quality is high, but the price is cheap
