It is also worth considering the use of machine learning methods to automatically identify and classify idioms. This will not only speed up the process of compiling the dictionary, but also ensure its higher accuracy.

Despite a detailed analysis of the HSG vocabulary, the current study has a number of limitations. Firstly, it is based solely on the HSG analysis, which may not give a complete picture of the methodology for compiling idiomatic dictionaries in general. Secondly, the study is limited to data from EUROPARL, and may not take into account idiomatic expressions from other contexts.

In the future, it would be useful to expand the analysis to include other idiomatic dictionaries, which would allow for a broader understanding of the methodologies used. It is also worth considering the possibility of using modern technologies to optimize the process of compiling dictionaries and improve their quality.
