In "Smart Villages" there are also ATM pharmacies that sell medicines (3).

In Germany, the "Smart Village" project is implemented in 4 locations, the largest of which is in the city of Eisenberg. Smart trade and logistics, smart energy methods are used here (2).

In Finland and Lapland, e-education, e-medicine, alternative energy, e-commerce and transport have developed: "For example, in Lapland, such an application has been created for mobile phones that a person who wants to go to the city enters this program and sees who will go to the city tomorrow and how many free spaces are there in the car?
